- The Agents must submit a copy of **valid Ticketing License and Tax Clearance** certificate issued by the Ministry of Industry, Commerce & Employment.
- The sealed bids shall be accompanied by EMD of **Nu.10,000/- (Ten Thousand only)** in the form **Demand Draft and Cash Warrant** (addressed to CFO, FD, DoSS, MoESD) which will act as bid and performance security
- Bids **without the EMD/PS** shall be not be Accepted and considered **Non-Responsive Bid**
- The Agents must submit a copy of **valid Ticketing License and Tax Clearance** certificate issued by the Ministry of Industry, Commerce & Employment.
- The seats should be confirmed before submitting the quotation without which your bids will be rejected without any further explanation.
- The quoted rates **shall not** be subject to change for duration of **5 hours after the opening of the quotation**.
- The Transit time must be minimum of 3 hours upto maximum of 6 hours.
