1. The Kingdom of Bhutan has received financing from the Asian Development Bank (ADB) toward the cost of Pathways for Emerging Skills and Jobs Project (PESJP). Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Department of Workforce Planning and Skills Development (DWPSD), Ministry of Education and Skills Development ("the Employer") invites sealed bids from eligible Bidders for the Construction of Infrastructures at Technical Training Institute-Rangjung, Trashigang (W-04) to include Academic Block, Lecture Theater renovation, Site development works & Water and Sewer Network.
3. Open competitive bidding will be conducted in accordance with ADB's Single-Stage: Two-Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

**a) Contract of Similar Size and Nature:**

Participation in at least one contract that has been successfully or substantially completed within the last 5 (five) years and that is like the proposed works (similar works means building works) with contract value not less than **Nu.135.000 million**.

**b) Average Annual Construction Turnover:**

The bidder must have a minimum Average Annual Construction Turnover of **Nu. 126.000 million**, calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years.

**c) Financial Resources:**

The Bidder must demonstrate that its financial resources, less its financial obligations for its current contract commitments, meet or exceed the total requirement for the Subject Contract of **Nu. 21.000 million**.
